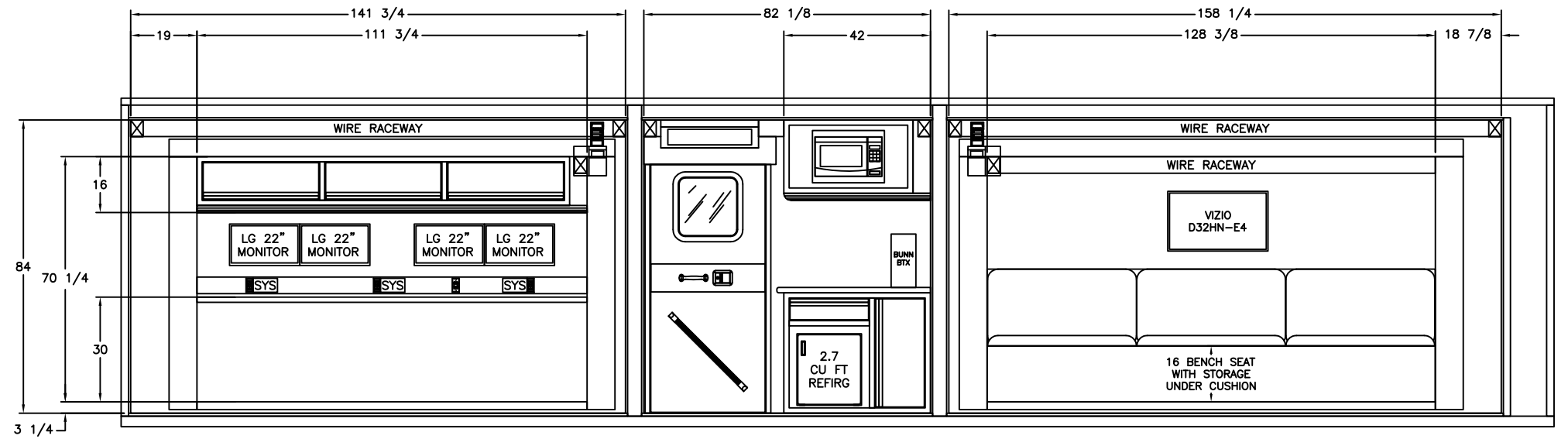

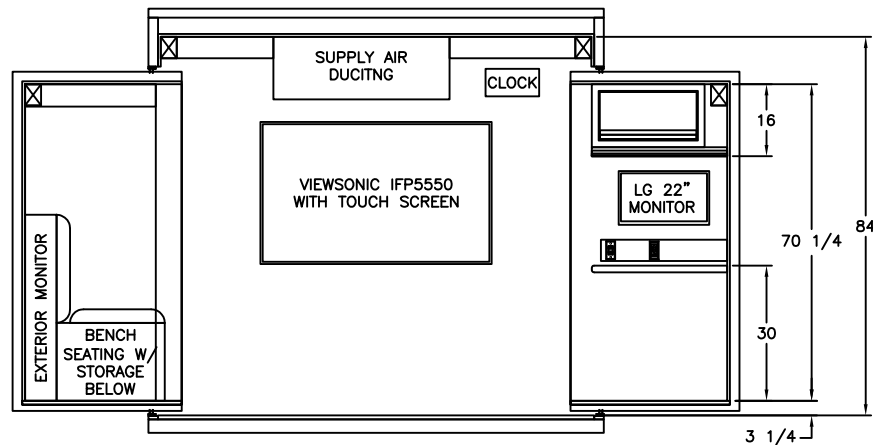

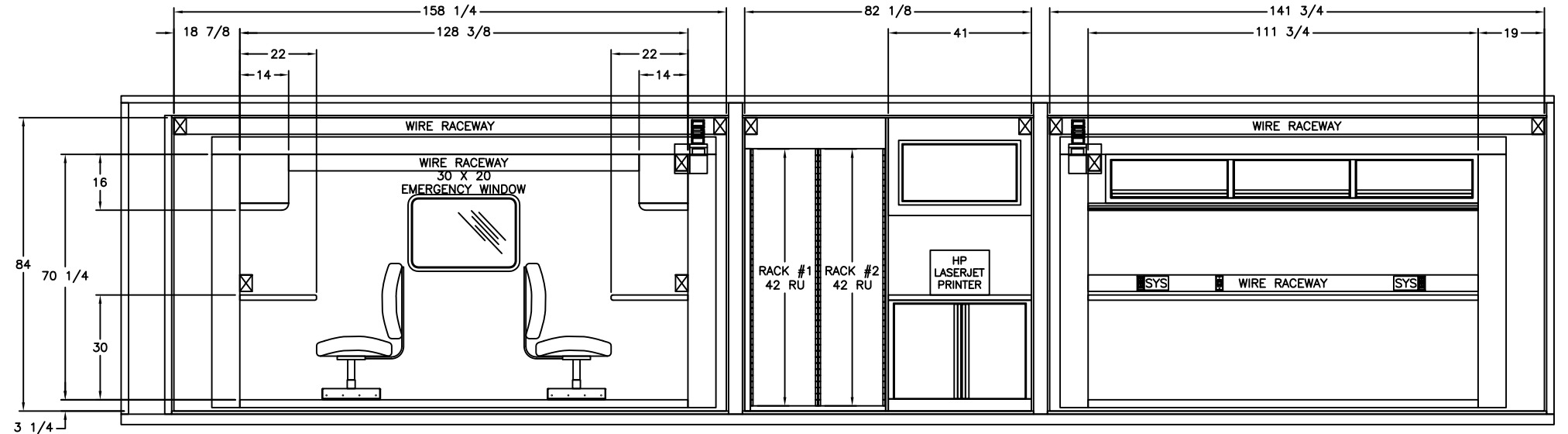
FRONT WALL INTERIOR LAYOUT
